This is up £4,000 from the previous year.</li> <li>In total including assets the club around £60,000.</li> </ol>	
Outgoings	<ol> <li>A new company is being sourced to empty the portaloos as the current company is unreliable.</li> <li>All agree that Ray Grant will be carrying out the financial audit for the club so he will have access to the clubs financial information.</li> </ol>
